Procedures for ad valorem property tax exemption on semi-trailers:

Single Semi-Trailer: (Non-Fleet)

To remove taxes on semi-trailers customer will need submit one
(1) of the following with PVA form:

1. A current Cab Card (needs to cover January 1st of the tax year)
2. An IFTA License (needs to cover the tax year)
3. A Login Sheet (1 page that shows trailer was pulled out of state dated January-March of the tax year)

Fleet Semi-Trailers:

Motax form 62A044-T affidavit must be submitted along with semi-trailer list with the following information for each trailer receiving the exemption along with IFTA license:

1. License Plate
2. VIN
3. Year
4. Make
5. Model

The Affidavit must be completed by the IFTA licensee owning the semi-trailers to receive the exemption under [KRS 132.760\(2\)](#).
