

### A Message from Colleen

## Greetings and Happy New Year from your Jefferson County PVA.

2024 was a banner year for our office: recordsetting public meeting attendance, overcoming unprecedented challenges resulting from a statewide database conversion, recognition of the accuracy and fairness of our assessments through a biennial audit by the Department of Revenue and a special review commission, milestones in staff education and tenure, and winning numerous national and statewide awards. I am incredibly proud of the work our office does to meet challenges and set new standards of service for the people of Jefferson County.



This annual report seeks to advance several of the core objectives of my administration: increased transparency, best-in-class customer service, and demystifying the important work we do for the public.

In 2024, we reassessed nearly **97,000** properties across **MLS Areas 2, 3** (areas east of I-65 inside the Watterson Expressway) and **Area 7** (including Buechel, Jeffersontown, and extending out to the county line). Jefferson County's 2024 assessment roll grew by \$9 billion to a total of \$92.5 billion—the single largest source of revenue for the Commonwealth of **Kentucky.** 

In late April, we will release 2025 reassessments for MLS Areas 5 & 6, which covers the south-central portions of the county. We will continue to grow our public outreach efforts to ensure taxpayers understand their assessment and how to exercise their right to appeal. Information on 2025's public meetings and the appeal process will be available on our website starting in late February.

As always, thank you for the opportunity to serve as your Property Valuation Administrator. My professional pledge to you is that I will always work hard to continue to grow trust and confidence in this office.

## 2024 Annual Report Motor Vehicles

Our Motor Vehicles Department values vehicles, reviews vehicle valuation appeals, and maintains the county's property tax roll for motor vehicles, trailers, boats and aircraft.



The department also works with the county clerk to resolve tax-related clerical issues supporting vehicle ownership transfers, and processes thousands of business tangible property tax returns and motor vehicle dealer inventory lists each year. A statewide database conversion

in January 2024 created **unanticipated, unprecedented challenges** for our Motor Vehicles team. A huge volume of clerical cleanup work was needed, and calls from the public, vehicle dealers, and other government agencies to resolve immediate concerns inundated the staff.

The department's seven staff members answered nearly 30,000 phone calls in the first quarter of 2024 alone!

Can-do attitude, creative problem solving, and supportive teamwork exemplified by the Motor Vehicles Department's staff were key to powering through the workload and ensuring the public's needs were met.

#### Improvements For Military Servicemembers

Non-resident active-duty military service members stationed in Kentucky and their spouses can qualify for a property tax waiver on motor vehicles registered in Kentucky in accordance with federal law. Our IT and public engagement teams collaborated with the Motor Vehicles Department to clarify requirements and create a convenient online application using our website's Online Portals. We can now serve military personnel and their families better than ever before.



#### KAVIS CONVERSION

Growing pains were expected when the state transitioned from a 1970's database system to the modern KAVIS (Kentucky Automated Vehicle Information System) in January 2024.

Jefferson County accounts for a significant percentage of the state's motor vehicle transactions, so the **impacts were** magnified for our team and the public we serve. The team worked to troubleshoot, consult with the software development team, clean up data, field a record number of phone calls, and power through layers of clerical work with one objective in mind: to make this change as seamless as possible for the public.

A year on, many benefits of the KAVIS system have become clear, and the system is demonstrating itself as an improved tool for our staff to serve the public.




